Fuel statement: Costa may charge a cruise fuel supplement of up to \$9 pp per day if the NYMEX oil price exceeds \$70 per barrel.

CANCELLATION AND REFUND POLICY

A cancellation before July 17, 2012, will receive a full refund, less a \$150pp USD administration fee. Passengers who cancel after that date for any reason, including medical reasons, are also subject to the additional fees set by Costa Cruise Lines as follows:

- \$500 USD pp deposit fee for any cancellation from July 17, 2012, through August 19, 2012.
- 50% of cruise fare in USD for any cancellation from August 20, 2012, through September 14, 2012.
- 75% of cruise fare in USD for any cancellation from September 15, 2012, through October 2, 2012.
- 100% of cruise fare in USD for cancellation from October 3, 2012, to date of sailing.

PLEASE NOTE: Costa insurance is available to US and Canada citizens up to 90 days prior to sailing, or on date of booking thereafter, for \$179 per person. Tango at Sea offers door to door travel insurance through Access America Travel Insurance. Premiums are based on cost of travel plus the age of the traveler. Full details are listed under the Travel Insurance tab on our website. Our guests are required to carry travel insurance.

REFUNDS

Refund requests must be made in writing by fax or by email ONLY. Processing time for refunds will occur after the sailing ends on October 27, 2012. Deposit receipt, cruise tickets, airline tickets, transfer coupons and all other vouchers must be returned before a refund can be made.

In most cases the refund will be processed via Tango at Sea company check. Administration fees must be paid to Tango at Sea Agency before cruise cancellation can be completed.
